WATER

Requests have been made for the water supply to be turned on outside of the usual March to October time.

The Council are not obliged to supply water to the allotments but do so on a metered basis. Due to the damage done and expense from a previous frozen pipe and for ongoing financial reasons the water will continue to be turned on in the Spring and off at the end of the Autumn.

If you do not have a water butt it would be worth looking into this before the winter to ensure you have water when the supply is turned off.

BONFIRES & BBQs

The Council has received complaints from residents in both Gravits Sandringham Way regarding smoke from bonfires and BBQs.

Short, sharp bonfires are permitted for the disposal of green waste only. All other rubbish should be taken away and disposed of off-site. Bonfires should be put out on leaving the site and tenants mindful of smoke should be residential area. BBQs are permitted but must be disposed of off-site and fully extinguished after use.

ANNUAL AWARDS


