MINUTES OF THE EVENTS COMMITTEE MEETING

22. CHAIRMAN'S ANNOUNCEMENTS AND APOLOGIES OF ABSENCE

The Chairman welcomed those present. Apologies of absence were noted as being received from Cllr. Mrs. J. Gillibrand, Cllr. Mrs. J. Walker, Cllr. Mrs. J. Warr and Cllr. P. Wells.

In accordance with good practice, individual forms were available to those Councillors present in order that they could personally record their interests - both Prejudicial and Personal. These forms to be returned to the Committee Clerk at the end of the meeting to enable all declarations of interest to be accurately recorded in the Minutes.

Cllr. J. Passingham declared a Prejudicial Interest in relation to events organised by Bognor Regis Seafront Lights.

24. TO APPROVE MINUTES OF THE MEETING HELD ON 7th JANUARY 2008, PREVIOUSLY CIRCULATED

The Minutes of the Meeting held on 7th January 2008 were amended to read 'Cllr. P. Wells declared a Prejudicial Interest in all matters relating to International Bognor Birdman and left the Council Chamber.' under Minute 19.1.

The Minutes of the Meeting held on 7th January 2008 as amended, were then agreed as an accurate record and were signed by the presiding Chairman.

Members were made aware of the current progress on the 2008 Events (Appendix 1) and advised that updates have been highlighted in red. In response to a query, the Events Officer advised that it was unlikely that the 2008 Clowns Budget would be spent.

Proposal:

28. TO APPROVE ALLOCATION OF TOWN FORCE HOURS FOR EVENTS 2008

The list that had been prepared by the Events Officer was detailed and the Committee **RESOLVED** to approve the allocation of Town Force hours as attached - Appendix 2.

Concern was expressed over the format of the Application for Town Force hours. It was felt that not enough detail was being provided for the Town Force team to carry out their duties safely and efficiently. Therefore revision of the form was currently underway. It was also stressed that it is BRTC Policy to charge the organisation for any Town Force time over and above the free hours allocated.

Cllr. K. Scutt offered his apologies and left the meeting at 7.25pm.

29. TO CONSIDER PURCHASE OF CHAIRS AND TRAILER (P&R MINUTE NO.77 23rd OCTOBER 2007 REFERS)

The Events Officer reported that this was originally proposed to speed up the process of setting up for bandstand concerts and similar and to save Town Force time. It had been suggested that a trailer system to hold the chairs could also be investigated. However due to the number of concerts being organized for this year, it was felt that the matter should be put on hold and re-considered next year. This was **AGREED.**

Update:

Booking of entertainment is ongoing

Our usual supplier for the donkeys is not able to help this year but we have identified an alternative source and are in negotiations with them

To date we have received 10 bookings for craft stalls and 23 bookings for the vehicle cavalcade We will be running the children's activities in the grounds of the Royal Norfolk Hotel on the Saturday Sponsorship for the event is being sought

Bognor Regis Festival

Agreed at previous meeting:

A. Budget for this was cut. Events officer would pursue alternative funding

Update:

I would like to pursue this idea if possible, as I feel that with the Heritage days falling in September and the opening up of Hotham Park after the works have been completed, these would form the basis of a good local Festival

I would like the Events Committee's decision on whether I should pursue Awards for All funding. Each organisation can apply for up to £10,000 in any 2 year period. We received £3,500 for Sands of Time last year so we could apply for up to £6,500 this year.

A. That a bid for Awards for All funding be made for the Bognor Regis Festival

French Market
