We are not able to remove it and it is unfair to expect others to clear up after you. If you bring anything to the allotments it is up to you to take it away. Anyone found littering will receive a warning and continued littering will lead to a Notice to Quit being issued.

WINTER MAINTENANCE

May we remind everyone that plots must be kept tidy and well maintained over the Winter period and not be allowed to get overgrown. Site visits will continue over this period. Can we also ask that those with sheds and greenhouses keep a check following periods of high winds with any damage attended to promptly.

You are responsible for keeping the edges and paths around your plots cut and tidy.
