



## **Safer West Sussex Partnership Survey 2018**

### **Overview**

The Safer West Sussex Partnership (SWSP) brings together Community Safety Partnerships (CSPs), along with other key agencies, to provide a coordinated approach to reducing crime and anti-social behaviour in West Sussex.

The partnership has 6 key priorities that have been chosen through a combination of evidence from the Strategic Intelligence Assessment (SIA) and other relevant local profiles, legislative requirements from National Government and feedback from partner agencies regarding the threats and risks that they have identified in the last 12 months.

The priorities (in no particular order) are;

Child Sexual Exploitation (CSE)

PREVENT

Serious and Organised Crime (SOC)

Domestic and Sexual Abuse

Drugs and Alcohol

Modern Slavery

We are asking residents for their understanding, experiences and access to support and information around some of these priorities, in order that we can target activity where gaps may exist.

### **Cuckooing**

Criminal gangs targeting the homes of vulnerable people in order to deal drugs from them – this process is known as cuckooing and victims are usually left with no choice but to cooperate. Dealers often approach a vulnerable person, offering them free drugs in exchange for use of their home for dealing. In some instances they provide the vulnerable person with free drugs and then force them to deal for them in order to repay their drug debts. These criminals are selective about who they target. Cuckooing means the criminals can operate from a property rather than the street, which is out of sight making it a more attractive option. The criminals can then use the property to deal drugs from, usually only staying for a short period of time.

Modern Slavery includes circumstances where victims are forced or compelled to work via threats or harmful consequences and can include domestic servitude. It can also include the exploitation of workers who, perhaps because of their origins or circumstances, appear to work willingly. Modern Slavery also includes Human Trafficking, where victims are recruited, their travel from A to B is facilitated by coercion or deception in order that they can be exploited sexually, by work or to commit crime. Although human trafficking often involves an international cross-border element, it is also possible to be a victim of modern slavery within your own country.
