ANNUAL AWARDS

The last Annual Awards were in 2019.

The Allotments Sub-Committee have agreed that annual awards will be reinstated this year. As a reminder, and for the benefit of new tenants, the awards are for:

- \Rightarrow The Roy Gristwood Shield for Best use of a plot
- \Rightarrow Most improved plot on each site
- \Rightarrow Best kept plot Original Site
- \Rightarrow Best kept plot Re-established site: The Sharon Stubbings Award

All plots are entered automatically and judging will take place in July/ August 2022.

The winners will be announced at the Annual Awards Event which is planned for October 2022.

REMINDER OF PLOT-HOLDERS OBLIGATIONS:


Whilst the majority of plot-holders are maintaining their plots in accordance with their Tenancy Agreement and the Allotment Guidelines we do have a number of areas of concern which include:

- \Rightarrow Trees must NOT exceed a height of 8ft or 2.5m. This is to stop the shading of neighbouring plots. So please prune your trees at the earliest opportunity.
- ⇒ Plants should not OVERHANG fences or footpaths. So please prune accordingly. Similarly, do NOT take it upon yourself to prune back vegetation on other tenant's plots. Speak to the tenant or your representative if you feel there is vegetation causing problems.
- \Rightarrow Rubbish. Please take away YOUR rubbish. This includes garden waste that is not being placed in a purpose built compost heap or compost bin.
- \Rightarrow Health & Safety. REMOVE all broken glass, damaged greenhouses and other hazards. Also please do not leave out tools on your plot.
- ⇒ Fences & hedges. All tenants with plots along the allotment boundary are required to keep the boundary clear of any obstructions including long grass. This is to enable Town Force access to cut hedges, maintain fences etc. NOTHING should be placed against the fences.
- ⇒ Cultivation. You must keep your plot free of weeds and plot edges tidy. I understand that the pandemic has made life difficult and has meant many of you have had less opportunity to attend to your plots. However, now is the time to get all the plots under cultivation as failure to do so will result in you receiving formal "Notice to Cultivate" letters.
- ⇒ Produce Theft. There are reports of produce being taken from plots. This is both illegal and against the ethics of what allotments stand for. Any tenants caught taking produce from other plots without permission will have their Agreement terminated immediately.

PLEASE NOTE: WEEDKILLER AND PESTICIDES ARE NOT ALLOWED ON THE ALLOTMENTS
