Bognor Regis Town Council has 146 allotment plots located at the Gravits Lane/Sandringham Way site that are rented to residents of Bognor Regis. Plots range in size from 24m² to over 300m². In the past eight months 15 plots were rented out to new tenants and currently there is a waiting list of 33.


The competition's aim is to help make the town a nicer place to shop, work or visit, whilst importantly focusing on what we can do in our gardens to help the battle against climate change.

Allotment Holders' Annual General Meeting

The 2022 Allotment Holders' AGM was held on 25th October 2022 at 7pm. The Town Council responded to questions from tenants on a number of financing issues.

RENT RISES

A tenant queried the increases in some annual rents this year.

It was confirmed that those rises were a result of equalising rents across all plots to an amount of 28p per square metre. The rent rises were not across all plot-holders and the Town Council will not be seeing a large increase in its revenues.

HOLDING DEPOSITS

A tenant asked if Holding Deposits were retained when Town Force had to make good the plot of a departing tenant. The Town Council was able to advise that deposits are always withheld to cover the cost of Town Force making good plots that are not vacated in a tidy condition.

COST OF RUNNING THE ALLOTMENTS

The Town Council was asked if it made a profit from the allotments and could the accounts of the allotments be published.

The Town Council can report it does <u>not</u> make a profit from the running of the allotments and that allotment accounts are published monthly on the Town Council website.

Allotments Shelter & Additional Fencing

SHELTER

At the latest Allotments Sub-Committee Meeting approval, in principle, was granted to install a shelter on the Re-established site.

A location close to the Gravits Lane gate has been identified that will not shade or crowd any neighbouring plots. Tenant Reps and nearby tenants have been given the opportunity to comment on the location, size etc.

It is hoped the shelter will be installed by Town Force in the spring.

Height of Trees

The height of trees on the allotment plots is a topic that has been raised by many tenants.

The current allotment information leaflet states that only fruit trees can be planted and that they should not overgrow your plot nor exceed 8ft in height.

The height restriction could be amended

FENCING

Having surveyed the Original site it is clear that there are parts of the boundary that have not been fully or properly fenced.

The Council will be looking for quotes to complete the fence by plot 1 and plots 5a & 5c as well as fencing the northwest boundary where there is currently a low fence and hedge.

It is anticipated this work will be done before the next growing season.

later this year so that fruit trees can be grown to 10ft (or 3m) so long as they DO NOT overgrow your plot OR shade a neighbouring plot.

This tree height rule will be enforced more robustly in 2023 so you are encouraged to carry out your winter pruning with these heights in mind.





Musts and Must Nots

Tools should not be left out on the plot. They MUST be stored in your shed or taken home with you. As a reminder the Town Council is not responsible for loss or damage to any gardening equipment, sheds or greenhouses owned or used by the tenant.

Most plots are in good or very good condition which is great to see. However, there are plots that are in a poor state of cultivation. During this coming year tenants of those plots will be expected to cultivate and maintain their plots, otherwise Warning Letters and, potentially, a Notice to Quit will be issued.

Theft of product and damage to equipment has been reported on a few occasions, including over the recent Christmas holiday. This is unacceptable and contrary to the general ethos of what allotments stand for and must not happen.
