ALLOTMENT WATCH SMARTWATER PROPERTY PROTECTION DAY

We have received notification from Sussex Police that it is their intention to hold another Allotment Watch SmartWater Property Protection day on Sunday 14th June between 11.30am and 12.30pm at the Gravits Lane allotments. This is a free service, recognised nationally and items are registered on a national database. Please try to attend so that you can register your gardening equipment and take steps to protect your property in the event of theft.

HOW DOES SMARTWATER WORK?

SmartWater is a Police Approved Forensic Property Marking Solution that is similar in concept to DNA. The solution is simply painted onto any item of property and left for a few minutes to dry, each bottle contains a unique chemical DNA "barcode" that is registered on a secure database to the owner of the items marked.

RENTAL INCREASE FOR 2009-2010

Tenants' representatives will also have extra copies in case anyone mislays their form. Please show your support for the hard work your fellow tenants have put into their plots and vote.

The Young Achievers Awards will again be presented this year at the Allotment Holders A.G.M. If your children or grandchildren have helped you tending your plot and you would like them to receive a certificate for their hard work on the allotments, please let us know. RE-ESTABLISHED SITE PADLOCKS
