The Meeting opened at 6.30pm

201. CHAIRMAN'S ANNOUNCEMENTS AND APOLOGIES FOR ABSENCE

In the absence of the Chairman, Cllr. Goodheart, Members **AGREED** that the Vice-Chairman, Cllr. Mrs. Warr, would chair the meeting. Members further **AGREED** that Cllr. Barrett should act as Vice-Chairman for this meeting only.

The Chairman welcomed those present and went through the evacuation procedure in the event of a fire. Apologies for absence had been received from Cllr. Erskine, who was away, and Cllr. Goodheart due to unforeseen circumstances. No apologies had been received from Cllr. Smith.

- e) if it is a Disclosable Pecuniary Interest, and therefore must leave the room for the discussion and vote, whether they will be exercising their right to speak on this matter under Public Question Time

They then need to re-declare their Interest and the nature of the Interest at the commencement of the item or when the Interest becomes apparent. They should request that it be recorded in the Minutes that they will leave the meeting and will neither take part in discussion, nor vote on the item.

AGENDA ITEM 10 - TO DISCUSS THE FUTURE OF WSCC'S JWAAC HIGHWAYS & TRANSPORT SUB-GROUP

REPORT BY THE CIVIC & OFFICE MANAGER

FOR DECISION

West Sussex County Council (WSCC) has advised that, as of April 2020, WSCC Democratic Services team will no longer be able to support the Joint Western Arun Area Committee (JWAAC) Highways & Transport Sub-Group. The decision was made after careful consideration due to staffing capacity in the team. Whilst WSCC will be withdrawing admin support, they have confirmed that Highways Officers will continue to serve the meetings as they do now.

In recognising the importance of the Sub-Group Meetings, WSCC have suggested that the group will be able to continue in a way similar to the Joint Eastern Arun Area group. They meet independently and, it is believed, Clerks from Town/Parish Councils share the support between them for the year. Councils could pay a similar fee to one or more Councils to continue to clerk the meeting.

Should Town/Parish Councils within the Joint Western Arun Area wish for the Highways & Transport Sub-Group meetings to continue then they would need to organise their own meeting dates, agendas/minutes and invite the WSCC Highways Officers.

Bognor Regis Town Council has one representative, and one reserve, appointed to the JWAAC Highways & Transport Sub-Group.

The Chairman of Arun District Association of Local Councils (ADALC) has written to its Members, of which the Town Council are one, asking for views and offering to set up a meeting to take this forward (attached as **Appendix 1**).

DECISIONS

Do Members **AGREE** that ways in which JWAAC Highways & Transport Sub-Group Meetings might continue should, in liaison with other Town/Parish Councils in the Joint Western Arun Area, be discussed?

Do Members **AGREE** to meet with Members of ADALC to discuss the way forward?

HIGHWAYS AND TRANSPORT SUB-GROUP

In terms of immediate business, parishes and towns in the west of the District have been informed by WSCC of the cessation of **support** for the Highways and Transport Sub-Group of the Joint Western Arun Advisory Group. Although I cannot personally endorse the timing or the method by which this news was circulated, this does not mean that the meetings are no longer viable. It does mean that if we want to continue with these meetings – and I believe they are more than useful, we (in the west) will have to organise venues and secretarial support etc. using the same or similar model as the east of the District.

ADALC covers the whole District and could usefully be used to gather western parishes/towns views on this whilst the insight from those in the east could provide a model to progress. As it looks like this is going to happen, we might as well bite the bullet and get on with it. The number and progress of the strategic sites in the west and the associated highways matters will not wait for us.

I would be interested in your views on this and would be happy to set up a meeting to take this forward. As usual, the devil will be in the detail but we have to start somewhere.

AGENDA ITEM 11 - TO RECEIVE A REPORT REGARDING NON-COUNCILLOR MEMBERSHIP ON THE PLANNING AND LICENSING COMMITTEE

REPORT BY THE CIVIC & OFFICE MANAGER

FOR DECISION

At the Planning and Licensing Committee Meeting held on 18th February 2020, during Public Question Time and Statements, a member of the public asked about the possibility of non-Councillors being co-opted as non-voting Members of the Committee (Min. 204 refers).

Whilst legislation permits non-Councillors to be non-voting Members of the Committee this should only be done when they can offer specialist knowledge, expertise or because they represent sections of the local community that are relevant to the work of the Committee. For example, an open spaces or recreational facilities Committee may include non-Councillors who represent local sports clubs or schools. Additionally, when considering appointing non-Councillors to be Members of a Committee, regard should also be given to the Local Government Act 1972 ('the 1972 Act') in relation to such matters as disqualification, voting rights, code of conduct which may apply to a person being appointed under these circumstances.

It is the Clerk's recommendation that this matter is not progressed further for the following reasons: -

The complexities in appointing a suitable person, with the appropriate knowledge/expertise are vast. As would be the administration of eligibility checks to include employment, bankruptcy, and convictions, for example.

Provision is already in place for input from members of the public. Residents/non-residents who wish to make comment in relation to any planning application within the Wards of Bognor Regis may do so throughout the public consultation period. Such comments are brought to the attention of Committee Members at the relevant meeting. Standing Orders allow for members of the public to address Committee Members at meetings, during Public Question Time and Statements.

Although there are presently 2 vacant seats on the Planning and Licensing Committee, there are only two further meetings scheduled to take place before Committee Memberships are re-appointed at the Annual Town Council Meeting in May. It is hoped that all 9 available seats on the Committee will then be filled by Councillors.
