MINUTES OF THE EVENTS COMMITTEE MEETING

HELD ON TUESDAY 16th DECEMBER 2008

PRESENT:

CHAIRMAN'S ANNOUNCEMENTS AND APOLOGIES OF ABSENCE 52. The Chairman welcomed those present. Apologies of absence were noted as being received from Cllrs.: A. Cunard, J. Passingham and Mrs. J. Warr.

53. **DECLARATIONS OF INTEREST**

Members and Officers were reminded to make any declarations of personal and/or prejudicial interests that they may have in relation to items on this Agenda.

Notice should be given at this part of the meeting of any intended declaration. The nature of the interest should then be declared later at the commencement of the item or when the interest becomes apparent.

In accordance with good practice, individual forms were available to those Councillors present in order that they could personally record their interests - both Prejudicial and Personal. These forms to be returned to the Committee Clerk at the end of the meeting to enable all declarations of interest to be accurately recorded in the Minutes.

The Committee noted there were no Declarations of Interest made at this point in the Meeting.

TO APPROVE MINUTES OF THE MEETING HELD ON 4TH NOVEMBER 2008, 54. PREVIOUSLY CIRCULATED

The Minutes of the Meeting held on 4th November 2008 were agreed as an accurate record and were signed by the presiding Chairman.

55. ADJOURNMENT FOR PUBLIC QUESTION TIME

There were no questions.

56. MATTERS ARISING FROM THE MINUTES WHICH ARE NOT SEPARATE AGENDA ITEMS

The Events Officer informed the Committee that Hotham Park Heritage Trust submitted a grant aid application yesterday and read out the letter which accompanied the form. Members noted that the Town Clerk had informed Mrs. D. Strachan that the application could not be accepted as it was submitted past the deadline.

Min. 48 - The Committee noted that in consultation with the chairman and the chairman of P&R Committee, a brief press release was issued in connection with this matter. Subsequently, a letter from Mr. B. Jones was published in the Observer. It was reiterated that no grant aid application had been received and that other members of the International Bognor Birdman (I.B.B.) Committee were still concerned about the Health & Safety. It was queried whether there was a functioning I.B.B. Committee. Elected Member in the public gallery indicated that he would like the opportunity to participate in this debate. This was **AGREED**.

The Committee was informed of the difference of opinions within the I.B.B. Committee with regard to the safety of the event. Further, a Member spoke in support of the proposed independent H&S report.

Min. 50.3 – The Events Officer read out letter from the Concessions Officer, informing Members that the concession adjacent to the beacon had been closed down until it was ready to operate. It was noted that a demonstration for Members could be arranged.

Min. 44 – Min. No. 33.3 – The Events Officer will email the Head of Park & Greenspace regarding the BRTC funding. The Committee noted that the Events Officer had been invited to the Hotham Park launch planning meeting on 19 February.

57. <u>TO APPROVE EVENTS OFFICER'S REPORT - PREVIOUSLY CIRCULATED</u>

The Events Officer updated the Committee on the current progress as per her report (Appendix 1).

A Member commented positively on the Christmas Lights and the Switch on event. The Committee noted that an Events Degree graduate would start his work experience in January.

The Events Officer's report including the budgets was APPROVED.

58. <u>TO RECEIVE UPDATE ON PROPOSED CARNIVAL 2009 FROM THE EVENTS OFFICER</u> <u>AND DECIDE ON DATE CARNIVAL IS TO BE HELD</u>

The Events Officer asked the Committee for a decision on a date and a route. Various options for the route were presented and some discussion followed. It was noted that Hotham Park was not an option however the ADC Events Development Officer had suggested closing the Town Hall car park for the evening entertainment. Members noted that this had not yet been consulted with the ADC Car Parks Department. The Events Officer reminded Members that if any funding was to be secured for 2012, a Carnival would be the best bet. A suggestion to reverse the route, start in West Park and finish on the seafront / Town Hall car park was made and some debate followed.

Cllr. Mrs. S. Daniells offered her apologies and joined the meeting at 7.04pm.

With regard to the date, 13th June 2009 was suggested. It had previously been proposed to tie the Carnival in with the funfair however as it is scheduled in for 21-28 July 2009, it was thought to be too close to Sands of Time. The date of 13th June 2009 was **AGREED**. Following detailed debate on the route, the Committee **AGREED** in principle that the town centre, either the seafront or the Town Hall car park, be the starting point and the procession would finish in West Park. This is subject to the Events Officer obtaining the appropriate permissions.

The issue of vehicle ban in Hotham Park was raised and a Member suggested writing to ADC asking for dates of their events to ensure that BRTC events do not collide with theirs.

59. <u>TO CONSIDER USE OF BEACON AS A MEANS OF SUPPORTING THE OLYMPICS (E&L</u> <u>COMMITTEE MINUTE 88.6 REFERS)</u>

Elected Member in the public gallery indicated that he would like the opportunity to participate in this debate. This was **AGREED**. Cllr. J. Brooks spoke of his suggestion to E&L Committee to lit the beacon by an artificial lamp which could be put on time clock. Other coastal resorts that have beacons such as Worthing and Brighton could also be encouraged to take part. Cllr. J Brooks **AGREED** to investigate the cost and report back to the Committee.

It was further reported that Cheltenham Racecourse had about 150 stackable plastic chairs to give away and the Events Officer agreed to liaise with Cllr. J. Brooks on this.

60. <u>UPDATE FROM EVENTS OFFICER ON PLANNING FOR THE CULTURAL OLYMPIAD</u>

It was noted that the next meeting was scheduled in for tomorrow. Members noted membership of this group and various initiatives that have been talked about. It was further noted that most of the funding was going to regions.

The Committee engaged in a detailed discussion on the issue of events in Hotham Park and the instruction that no vehicles would be allowed to drive over the grass. The logistical problems of trying to run an event in the Park were considerable and Members felt strongly about this issue. The subject of the Town Council's contribution was also raised. It was felt that the Park was there to be used by and for the community, there was also an expectation that events would be run there. In view of the concerns, it was suggested that this matter be referred to the full Council and the Head of Parks and Green Space be invited along to the meeting.
